Kementerian Kewangan dan Ekonomi dengan ini sukacita memaklumkan bahawa Kebawah Duli Yang Maha Mulia Paduka Seri Baginda Sultan dan Yang Di-Pertuan Negara Brunei Darussalam telah memperkenankan bagi *Companies Act (Amendment) Order, 2018* dan *Companies (Striking Off) Rules, 2018* yang dihasratkan untuk mengukuhkan lagi rangka perundangan Akta Syarikat-Syarikat (Penggagal 39) di Negara ini untuk berkuatkuasa mulai dari 13 September 2018.

*Companies Act (Amendment) Order, 2018* diperkenalkan bagi mengukuhkan lagi Akta Syarikat-Syarikat khususnya dengan mewujudkan peruntukan-peruntukan serta peraturan-peraturan mengenai *Companies (Striking Off) Rules, 2018* berhubung dengan pemotongan daftar nama syarikat kearah memastikan sistem penguatkuasaan syarikat-syarikat adalah lebih berkesan disamping mengukuhkan lagi dasar Akta tersebut berhubung dengan pemotongan pendaftaran nama syarikat.

The Ministry of Finance and Economy is pleased to announce that His Majesty the Sultan and Yang Di-Pertuan of Brunei Darussalam has consented for the introduction of the Companies Act (Amendment) Order, 2018 and Companies (Striking Off) Rules, 2018 which are aimed to further strengthen the Companies Act (Chapter 39) in Brunei Darussalam with effect from 13 September 2018.

The Companies Act (Amendment) Order, 2018 is introduced to further strengthen and support the provisions of the Companies Act (Chapter 39) and introduces the Companies (Striking Off) Rules, 2018. This is to ensure a more effective enforcement system for striking off companies from the Register.
