PENUBUHAN *INCOME TAX BOARD OF REVIEW***

Kementerian Kewangan sukacita memaklumkan bahawa Kebawah Duli Yang Maha Mulia Paduka Seri Baginda Sultan dan Yang Di-Pertuan Negara Brunei Darussalam telah memperkenankan bagi penubuhan *Income Tax Board of Review*.

Penubuhan *Income Tax Board of Review* ini bertujuan untuk memperkesakan lagi pentadbiran dan operasi percukaian di Negara Brunei Darussalam. *Income Tax Board of Review* ini memperkenalkan proses baru yang mana Lembaga ini akan mendengar, meneliti dan memberi keputusan ke atas kes bantahan daripada syarikat-syarikat terhadap taksiran Pemungut Cukai Pendapatan. Ia juga akan mewujudkan sistem pentadbiran cukai korporat yang lebih telus dan saksama kerana kes-kes bantahan tersebut akan diteliti oleh sebuah badan bebas.

Syarikat boleh mengemukakan rayuan mereka secara bertulis kepada Setiausaha *Income Tax Board of Review*, Pejabat *Income Tax Board of Review* di Tingkat 4, Bangunan Kementerian Kewangan, Commonwealth Drive, Jalan Kebangsaan BB3910, Negara Brunei Darussalam. Bayaran sebanyak BND\$200.00 dikenakan bagi setiap kes rayuan.

ESTABLISHMENT OF THE INCOME TAX BOARD OF REVIEW**

The Ministry of Finance is hereby pleased to announce that His Majesty the Sultan and Yang Di-Pertuan of Brunei Darussalam has consented for the establishment of the Income Tax Board of Review.

The establishment of the Income Tax Board of Review aims to facilitate the administration and operation of taxation in Brunei Darussalam. The Income Tax Board of Review introduces a new process of hearing, examining and settlement of objection cases from companies against the Collector of Income Tax's assessment. It will create a more transparent and fair system of administration of corporate tax as objection cases will be reviewed by an independent body.

Companies may present their appeal by writing to the Secretary of the Income Tax Board of Review, Income Tax Board of Review office at Level 4, Ministry of Finance Building, Commonwealth Drive, Jalan Kebangsaan BB3910, Brunei Darussalam. A fee of BND\$200.00 is chargeable for each appeal.
