Audit Department gets exposure on combating bid-rigging

Date: 02 August 2020

1. Bid rigging, also known as collusive tender, is agreements between bidders to eliminate competition in the procurement process, thereby raising prices and lowering quality. It is a major risk to the integrity and effectiveness of public procurement, and deprives the public sector of genuine opportunities to achieve value for money. Procurement units and their officials are therefore encouraged to learn and execute preventive measures to combat bid rigging.
2. Raising awareness of bid rigging risks has proven to be an important step to prevent the anti-competitive conduct, in ensuring value for money in public procurement, in line with Brunei Darussalam's national agenda to promote efficient use of public resources and prudent spending. This was highlighted by the Competition Commission Brunei Darussalam (CCBD) during a dialogue session with the Audit Department, Prime Minister's Office (PMO) that took place at Dewan Serbaguna, Bangunan Bahirah last week.
3. During the opening, the Executive Secretariat of the CCBD applauded the proactive move made by the Audit Department in requesting for the dialogue session to learn about the Competition Order, specifically, focusing on bid rigging prohibition.
4. More than 40 officials from the Audit Department were in attendance, led by the Auditor General, Yang Mulia Awang Haji Yusop bin Haji Mahmud. Representing the CCBD were Yang Berhormat Nik Hafimi binti Abdul Haadii, Chairperson of the CCBD, Commissioner Yang Mulia Pengiran Hajah Zety Sufina binti Pengiran Dato Paduka Haji Sani,

Permanent Secretary (Industry) at the Ministry of Finance and Economy, and Commissioner Yang Mulia Dayang Hajah Nor Hashimah binti Haji Mohd Taib, Deputy Permanent Secretary (Security, Enforcement and Law) at PMO.

5. The dialogue session discussed the key prohibitions of the Order, including prohibition on Anti-Competitive Agreements, which is already enforced since January 1, 2020; and shared recommendations consolidated from regional case studies; good practices from experienced competition authorities and; specific steps to render public procurement processes competitive in minimising risks of collusive tendering.
6. The Executive Secretariat of CCBD shared at great length on the different forms of bid rigging and the tools to detect and prevent bid rigging in public procurement. The session outlined some of the key measures to mitigate the risk of collusion, including, possessing market knowledge on a specific market; encouraging more bidders to participate in a tender; defining tender requirements clearly; and reducing communication amongst bidders. It is also important to include clauses stating bid rigging is an offence under the Competition Order in the tender document.
7. It was emphasised that procurement officials play a crucial role in bid rigging detection and should be vigilant on the warning signs of bid rigging, and to build a database to keep detailed records of bid documents. Any suspicious bidding patterns are to be reported to the CCBD, with substantial evidence, to enable investigation.
8. The session ended with an active dialogue deliberating on topics on the roles of the CCBD, application of the law, tender practices, as well as potential collaboration between the Audit Department and the CCBD in promoting competition in public procurement procedures and reducing the risks of bid rigging to ensure an efficient use of public resources.

SURUHANJAYA PERSAINGAN BRUNEI DARUSSALAM

Jabatan Audit mendapat pendedahan mengenai memerangi tipuan bidaan

Tarikh: 02 Ogos 2020

1. Tipuan bidaan, juga dikenali sebagai tawaran secara kolusif, adalah perjanjian di antara para penender untuk menghilangkan persaingan dalam proses perolehan, seterusnya menaikkan harga dan mengurangkan kualiti. Ianya merupakan risiko besar terhadap integriti dan keberkesanan perolehan awam, dan menyekat peluang sektor awam untuk mencapai *value-for-money*. Oleh itu, pegawai-pegawai perolehan adalah digalakkan untuk mempelajari dan melaksanakan langkah-langkah pencegahan bagi memerangi tipuan bidaan.

2. Meningkatkan kesedaran mengenai risiko tipuan bidaan telah terbukti menjadi langkah penting dalam mencegah amalan anti-persaingan berkenaan, ke arah memastikan *value-for-money* dalam perolehan awam, sejajar dengan matlamat Negara Brunei Darussalam bagi mempromosi penggunaan sumber awam yang cekap dan perbelanjaan yang berhemat. Perkara ini telah dibangkitkan oleh Suruhanjaya Persaingan Brunei Darussalam semasa sesi dialog bersama Jabatan Audit, Jabatan Perdana Menteri yang diadakan di Dewan Serbaguna, Bangunan Bahirah minggu lepas.

3. Pada sesi pembukaan dialog, Sekretariat Eksekutif Suruhanjaya Persaingan Brunei Darussalam memberi pujian terhadap langkah proaktif Jabatan Audit mengungkayahkan dialog untuk mempelajari mengenai Perintah Persaingan dengan fokus utama larangan tipuan bidaan.

4. Lebih daripada 40 pegawai dari Jabatan Audit menghadiri sesi dialog, diketuai oleh Juruaudit Agung, Yang Mulia Awang Haji Yusop bin Haji Mahmud. Mewakili

Suruhanjaya Persaingan ialah Yang Berhormat Nik Hafimi binti Abdul Haadii, Pengurus Suruhanjaya Persaingan, dan Ahli-Ahli Suruhanjaya Persaingan, Yang Mulia Pengiran Hajah Zety Sufina binti Pengiran Dato Paduka Haji Sani, Setiausaha Tetap (Industri) di Kementerian Kewangan dan Ekonomi, dan Yang Mulia Dayang Hajah Nor Hashimah binti Haji Mohd Taib, Timbalan Setiausaha Tetap (Keselamatan, Penguatkuasaan dan Undang-Undang) di Jabatan Perdana Menteri.

5. Sesi dialog membincangkan mengenai larangan-larangan utama Perintah Persaingan termasuk larangan Perjanjian Anti-Persaingan, yang mana telah dikuatkuasakan bermula Januari 1, 2020; dan mengongsikan cadangan-cadangan dari kajian kes serantau; amalan terbaik dari autoriti-autoriti persaingan yang berpengalaman dan; langkah-langkah khusus untuk menjadikan proses perolehan awam berdaya saing bagi mengurangkan risiko tawaran secara kolusif.
6. Sekretariat Eksekutif Suruhanjaya Persaingan mengongsikan secara mendalam mengenai jenis-jenis tipuan bidaan dan alat bagi mengesan dan mencegah tipuan bidaan dalam perolehan awam. Sesi berkenaan juga menggariskan beberapa langkah utama untuk mengurangkan risiko pakatan, termasuk memiliki pengetahuan mengenai pasaran tertentu; menggalakkan banyak penender menyertai tawaran; menentukan syarat-syarat tawaran dengan jelas; dan mengurangkan komunikasi antara penender. Juga penting untuk memasukkan klausa mengenai kesalahan tipuan bidaan di bawah Perintah Persaingan, di dalam dokumen tawaran.
7. Turut ditekankan bahawa pegawai-pegawai perolehan memainkan peranan penting dalam mengesan tipuan bidaan dan harus berwaspada terhadap tanda-tanda tipuan bidaan, dan seterusnya menyimpan maklumat data terperinci mengenai dokumen tawaran. Sebarang keraguan mengenai tren bidaan boleh diadukan kepada Suruhanjaya Persaingan, dengan bukti yang kukuh, bagi membolehkan siasatan dijalankan.
8. Sesi diakhiri dengan dialog aktif membincang topik-topik berkaitan fungsi Suruhanjaya Persaingan, pengenaan perundangan persaingan, amalan-amalan bidaan, serta potensi kerjasama di antara Jabatan Audit dan Suruhanjaya Persaingan bagi mempromosi persaingan dalam prosedur perolehan awam dan mengurangi risiko tipuan bidaan ke arah memastikan penggunaan sumber awam yang cekap.
