## 16<sup>th</sup> BIMP-EAGA HEADS OF CUSTOMS MEETING KUCHING, SARAWAK, MALAYSIA

- 1. Yang Mulia Muhammad Azizil Hakim bin Haji Brahim, Acting Controller along with Senior Officers from the Royal Customs and Excise Department, Ministry of Finance and Economy attended the 16th BIMP-EAGA Customs Heads Meeting. The meeting was chaired by YBhg. Datuk Wira Anis Rizana binti Mohd Zainudin, Director General of Royal Malaysian Customs Department.
- 2. The meeting was also attended by the Directors-General of Customs and Senior Customs officers of BIMP-EAGA, representatives from the BIMP-EAGA Facilitation Centre (BIMP-FC), the BIMP-EAGA Business Council (BEBC), and the Asian Development Bank (ADB). The main agenda discussed included projects update under the BIMP-EAGA Trade Facilitation Cluster, Customs Working Group; consultations with the private sector through BEBC on potential convergence projects; and technical assistance provided by ADB.
- 3. One of the key outcomes of the meeting was the endorsement of The Royal Malaysian Customs Academy (AKMAL) in Kuching, Sarawak, as the BIMP-EAGA Training Centre (BETC), which will serve as the main training hub for the Customs Administrations of BIMP-EAGA. Delegates also attended the official ceremony of the BETC, officiated by the Director General of Customs, Royal Malaysian Customs Department, followed by a briefing and tour of the training facilities. AKMAL is also recognized as a Regional Training Centre by the World Customs Organization (WCO). The meeting further agreed that the next BIMP-EAGA Heads of Customs Meeting will be held biennially, with the next session scheduled to take place in the Philippines in 2027.
- 4. Brunei Darussalam's participation in this meeting reflects the continued commitment of RCED in supporting the BIMP-EAGA agenda to strengthen regional economic integration, facilitate trade, and enhance cooperation among BIMP-EAGA member countries.
