1. Kementerian Kewangan dan Ekonomi (MOFE) melalui Bahagian Hasil telah mengadakan Sesi Pemberigaaan Cukai Pendapatan Korporat pada hari Selasa, 10hb., Jun, 2025 yang berlangsung di Bilik Serbaguna 2, Tingkat 3, Island Block, MOFE.
2. Sesi ini bertujuan untuk meningkatkan kefahaman kepada syarikat-syarikat perniagaan mengenai skop percukaian di Negara ini di samping untuk meningkatkan kesedaran terhadap obligasi dan tanggungjawab syarikat-syarikat perniagaan ke atas pematuhan Cukai Pendapatan Korporat.
3. Dalam taklimat tersebut, pegawai dari Bahagian Hasil telah menjelaskan secara menyeluruh antaranya tentang asas penaksiran cukai, pematuhan untuk pemfailan penyata cukai dan perkiraan cukai, selaras dengan Akta Cukai Pendapatan, Penggal 35.

CORPORATE INCOME TAX SOCIALISATION SESSION

1. The Revenue Division, Ministry of Finance and Economy (MOFE) held a Socialisation Session on Corporate Income Tax on Tuesday, 10th June 2025 which took place at Bilik Serbaguna 2, Level 3, Island Block, MOFE.
2. The session hopes to enhance common understanding with regards to scope of taxation among corporate taxpayers in the country, as well as to raise awareness on their obligations and responsibilities towards the compliance of Corporate Income Tax.
3. During the briefing, the officer from Revenue Division has explained in details, among others, on the basis of tax assessment, compliance on the filing of tax returns and tax computation, in accordance with the Income Tax Act, Chapter 35.
4. This session is part of the ongoing efforts made by the Ministry of Finance and Economy to further strengthen tax compliance and raise awareness about the importance of corporate taxes to the public, especially among taxpayers in this country.
