**TAJUK UTAMA: INDEKS HARGA PENGGUNA (IHP) MENINGKAT SEBANYAK 2.6 PERATUS
TAHUN-KE-TAHUN BAGI BULAN JUN 2020**

1. IHP bagi bulan Jun 2020 meningkat sebanyak 2.6 peratus tahun-ke-tahun berbanding dengan bulan Jun 2019. Harga Makanan dan Minuman Ringan mencatatkan peningkatan sebanyak 2.8 peratus. Manakala, harga Bukan Makanan mencatatkan peningkatan sebanyak 2.5 peratus.
2. Peningkatan IHP adalah didorong oleh peningkatan harga dan kos Pelbagai Barang dan Perkhidmatan (11.6 peratus); Makanan dan Minuman Ringan (2.8 peratus); dan Pakaian dan Kasut (11.5 peratus).
3. Kenaikan bagi harga Pelbagai Barang dan Perkhidmatan adalah disebabkan oleh peningkatan harga insuran, terutamanya insuran kereta, berbanding dengan tahun sebelumnya.
4. Manakala berikutan dengan import yang terhad disebabkan oleh kekurangan bekalan dan penularan jangkitan wabak COVID-19 di negara ini dan negara-negara jiran, ini telah menyebabkan kenaikan kepada beberapa harga Makanan dan Minuman Ringan terutama sekali bagi harga sayur-sayuran; minuman ringan dan daging yang diimport.
5. Peningkatan harga Pakaian dan Kasut pula adalah disebabkan oleh kenaikan harga pakaian, bahan untuk pakaian dan kasut.
6. Bagi perubahan bulan-ke-bulan, IHP bagi bulan Jun 2020 meningkat sebanyak 0.03 peratus berbanding dengan bulan Mei 2020. Indeks Makanan dan Minuman Ringan menurun sebanyak 0.6 peratus. Manakala, Indeks Bukan Makanan meningkat sebanyak 0.2 peratus.

7. IHP mengukur perubahan harga barang dan perkhidmatan yang dibayar oleh pengguna dalam satu tempoh masa yang ditetapkan dan dikumpulkan setiap bulan. Senarai barang dan perkhidmatan dalam IHP adalah berdasarkan maklumat perbelanjaan purata sebuah keluarga yang diperolehi melalui Kajian Perbelanjaan Keluarga. **HEADLINE: CONSUMER PRICE INDEX (CPI) INCREASED BY 2.6 PER CENT
YEAR-ON-YEAR IN JUN 2020**

1. *The CPI in June 2020 increased by 2.6 per cent year-on-year compared to June 2019. Prices of Food and Non-Alcoholic Beverages increased by 2.8 per cent. Meanwhile, Non-Food prices increased by 2.5 per cent.*
2. *The CPI increase was largely attributed to increases in the prices and costs of Miscellaneous Goods and Services (11.6 per cent); Food and Non-Alcoholic Beverages (2.8 per cent); and Clothing and Footwear (11.5 per cent).*
3. *The rise in prices of Miscellaneous Goods and Services was due to an increase in the price of insurance, specifically car insurance, compared to the previous year.*
4. *Meanwhile, limited imports due to the limited of supply and the spread of the COVID-19 disease in the country and neighbouring countries have led to a hike in the price of Food and Non-Alcoholic Beverages, mainly in the prices of imported vegetables, soft drinks; and meat.*
5. *The increase in the prices of Clothing and Footwear was due to the increase in the prices of garments, clothing material and shoes.*
6. *On a month-on-month basis, the CPI in June 2020 increased by 0.03 per cent compared to May 2020. The Food and Non-Alcoholic Beverages Index decreased by 0.6 per cent. Meanwhile, the Non-Food Index increased by 0.2 per cent.*
7. *The CPI is a measure of price changes of goods and services paid by the consumer in a specified period and compiled on a monthly basis. The list of goods and services in the CPI is based on the average expenditure per household from the Household Expenditure Survey (HES). 
