KEMENTERIAN KEWANGAN DAN EKONOMI

OPERASI PENGUATKUASAAN KE ATAS PASAR RAYA DAN GEDUNG PERNIAGAAN

Tarikh: 05hb Ogos 2022

1. Unit Sukatan dan Timbangan (SDT), Bahagian Industri dan Ekosistem Perniagaan (IBE) di bawah Kementerian Kewangan dan Ekonomi telah melaksanakan lawatan pemeriksaan tidak berjadual ke atas tujuh belas (17) gedung perniagaan. Operasi penguatkuasaan telah dijalankan pada hari Khamis, 04hb Ogos 2022.
2. Ianya merupakan tindakan penguatkuasaan yang dilaksanakan secara rutin dalam memastikan sebarang penggunaan alat sukat dan timbang bagi tujuan perdagangan adalah sah, tepat dan berdaftar selaras dengan Akta Sukatan dan Timbangan 1983 Penggal 151. Hasil daripada tindakan penguatkuasaan tersebut sebanyak 175 unit alat sukat dan timbang didapati digunakan di dalam premis perniagaan. Manakala 2 unit daripadanya gagal mematuhi Akta dan Peraturan Sukat dan Timbang. Pihak syarikat telah dikeluarkan Notis Peringatan dan dikehendaki hadir ke Pejabat Unit Sukatan dan Timbangan dalam tempoh 7 hari waktu bekerja dari tarikh notis dikeluarkan. Premis-premis perniagaan yang telah dibuat pemeriksaan adalah seperti berikut:

Menurut Yang Mulia Awang Allen On, Pengarah di Bahagian Industri dan Ekosistem Perniagaan (IBE), dalam tempoh tujuh (7) bulan kebelakangan, para penguatkuasa Unit SDT sentiasa aktif dalam membuat penguatkuasaan di premis-premis perniagaan seperti kedai runcit, kafe, restoran-restoran, kedai kek dan pastri, kedai jahit, tekstil dan peralatan/perkakas bahan binaan. Penguatkuasaan turut dilaksanakan di tapak-tapak perindustrian seperti kilang-kilang proses makanan, bata, bahan kitar semula, bengkel-bengkel kenderaan dan gerai atau pondok jualan di tepi jalan. Hasil daripada penguatkuasaan tersebut sebanyak 70 kawasan perniagaan telah dibuat pemeriksaan dengan mendapati sebanyak 1,308 unit alat sukat dan timbang yang digunakan bagi tujuan perdagangan.
4. Para peniaga dan pengguna alat sukat dan timbang adalah dikehendaki untuk sentiasa mematuhi Peraturan-Peraturan (Penelitian) Alat-Alat Sukatan dan Timbangan 1994; di bawah seksyen 3(2); setiap orang yang menggunakan atau ada pada miliknya untuk kegunaan perdagangan mana-mana timbangan, sukatan alat-alat untuk menimbang yang tidak dicap sebagaimana yang dikehendaki oleh peraturan ini adalah bersalah.
5. Hukuman denda sebanyak BND1,000.00 atau penjara selama 3 bulan atau kedua-duanya sekali dan timbangan, sukatan atau alat untuk menimbang yang tersebut itu adalah boleh dirampas dan sebarang kontrak, tawar-menawar, jualan atau urusan dagang yang dibuat dengan timbangan, sukatan atau alat untuk menimbang sedemikian adalah tidak sah.

INSPECTION VISIT TO SUPERMARKET AND GROCERY STORE

Date: 05th August 2022

1. Weights and Measures Unit (SDT), Industry and Business Ecosystem Division (IBE) under Ministry of Finance and Economy conducted spot check visits to seventeen (17) supermarkets and grocery stores on Thursday, 04th August 2022.
2. These visits are part of a routine enforcement exercise to ensure any weights and measures machines that is used for business purposes are registered and verified. During the inspection, SDT officers found 175 units of weighing machines. While 2 units have failed to comply with the Weights and Measures Act, 1983 Chapter 151 and the stipulated guidelines under the Act. The company was issued a Reminder Notice and is required to report to the Weights and Measures Unit Office within 7 working days from the date the notice was issued. 3. According to Yang Mulia Awang Allen On, Director of the Industry and Business Ecosystem Division (IBE), over the past seven (7) months, SDT conducted inspection on business premises such as supermarkets, grocery stores, café, restaurants, cake houses and pastries, tailor shops, textiles and hardware shops. In addition to this, the inspections were also conducted at industrial sites such as food processing factories, bricks, recycled materials, workshop and roadside stalls. During that period, SDT has conducted spot checks in 70 areas with checking 1,308 units of weights and measures machines that is used for business activities.
4. Traders and users of weight and measures machine are required to comply as stipulated in the Weights and Measures (Verification) Regulations, 1994 under section 3(2); Every person who uses or has in his possession for use for trade any weight, measure or instrument for weighing not stamped as required by this regulation shall be guilty of an offence.
5. The penalty for such offence is a fine of BND1,000.00 or imprisonment for three (3) months or both and instrument for weighing shall be liable to be forfeited and any contract, bargain, sale or dealing made by such weight, measure or instrument for Weighing shall be void.
