



- Year-on-Year means to compare prices with the same month in the previous year.





- Year-on-Year means to compare prices with the same month in the previous year.

HIGHLIGHTS

The overall Consumer Price Index (CPI) in December 2022 has **increased** by 3.3 per cent year-on-year from 103.6 in December 2021 to 107.0 this year. Both Food and Non-Alcoholic Beverages index and Non-Food index have recorded an increase of 5.1 per cent and 2.8 per cent respectively. Meanwhile, the Goods and Services indices have increased by 2.2 per cent and 4.7 per cent respectively.

On a month-on-month basis, the CPI has **increased** by 0.4 per cent compared to November 2022. The Food and Non-Alcoholic Beverages index and the Non-Food index have recorded an increase of 0.01 per cent and 0.5 per cent respectively.

For period-on-period, the overall CPI for January to December 2022 registered an increase of 3.7 per cent compared to the same period in 2021. Both Food and Non-Alcoholic Beverages and Non-Food index have recorded an increase of 5.1 per cent and 3.3 per cent respectively **(Table 1)**.

YEAR-ON-YEAR CHANGES (DECEMBER 2022 COMPARED TO DECEMBER 2021)

The CPI in December 2022 has increased by 3.3 per cent compared to the same month in 2021.

Based on the contribution to change, Miscellaneous Goods and Services has contributed 33.5 per cent to the overall year-on-year increase of the CPI in December 2022. This was followed by Food and Non-Alcoholic Beverages 30.8 per cent; and Transport 24.7 per cent (Figure 1 and Table 2).

Increases were recorded in:

- **Miscellaneous Goods and Services** 13.4 per cent due to increase in prices of insurance; other appliances articles and products for personal care; and community and family services;
- Food and Non-Alcoholic Beverages 5.1 per cent due to increase in prices of meat; rice and cereals; and fish and seafood (Table 3); and
- **Transport** 4.2 per cent due to increase in prices of passenger transport by air; motor cars; and spare parts and accessories of vehicles.

Decreases were recorded in:

- **Clothing and Footwear** 7.2 per cent due to decrease in prices of garments; clothing materials; and shoes and other footwear;
- **Communication** 2.6 per cent due to decrease in prices of telephone and telefax services; and telephone and telefax equipment; and
- **Furnishings, Household Equipment and Routine Household Maintenance** 0.7 per cent due to decrease in prices of household textiles; furniture and furnishings; and major tools and equipment.

CPI Year-on-Year Changes in December 2022



MONTH-ON-MONTH CHANGES (DECEMBER 2022 COMPARED TO NOVEMBER 2022)

The CPI in December 2022 has increased by 0.4 per cent over November 2022.

Based on the contribution to change, Transport has contributed 170.8 per cent to the overall month-on-month increase of the CPI in December 2022. This was followed by Restaurants and Hotels 11.9 per cent; and Housing, Water, Electricity, Gas and Other Fuels 3.5 per cent (Figure 2 and Table 4).

Increases were recorded in:

- Transport 3.4 per cent due to increase in price of passenger transport by air;
- **Restaurants and Hotels** 0.4 per cent due to increase in prices of restaurants, cafes, fast food outlets and others; and accommodation services; and
- Housing, Water, Electricity, Gas and Other Fuels 0.1 per cent due to increase in price of materials for the maintenance and repair of the dwelling.

Decreases were recorded in:

- **Clothing and Footwear** 8.1 per cent due to decrease in prices of clothing materials; garments; and shoes and other footwear;
- **Recreation and Culture** 0.2 per cent due to decrease in prices of cultural services; games, toys and hobbies; and stationery and drawing materials; and
- Furnishings, Household Equipment and Routine Household Maintenance 0.1 per cent due to decrease in prices of furniture and furnishings; household textiles; and carpets and other floor coverings.

Meanwhile, the Communication; and Education indices remain unchanged.

ANNUAL 2022

PERIOD-ON-PERIOD CHANGES (JANUARY - DECEMBER 2022 COMPARED TO JANUARY - DECEMBER 2021)

The overall CPI for 2022 has increased by 3.7 per cent year-on-year compared to the overall CPI in 2021.

Based on the contribution to change, Miscellaneous Goods and Services has contributed 31.5 per cent to the overall period-on-period increase of the CPI from January to December 2022. This was followed by Food and Non-Alcoholic Beverages 27.4 per cent; and Transport 25.0 per cent (Figure 3 and Table 5).


Increases were recorded in:

- **Miscellaneous Goods and Services** 14.1 per cent due to increase in prices of insurance; other services; and other personal effects;
- Food and Non-Alcoholic Beverages 5.1 per cent due to increase in prices of meat; oil and fats; and fish and seafood (Table 6); and
- **Transport** 4.8 per cent due to increase in prices of motor cars; passenger transport by air; and spare parts and accessories of vehicles.

Decreases were recorded in:

- **Communication** 1.1 per cent due to decrease in prices of telephone and telefax services; and telephone and telefax equipment; and
- Education 0.01 per cent due to decrease in price of pre-primary and primary education.

GOODS ACCORDING TO DURABILITY AND SERVICES

For December 2022, the indices for both Goods and Services increased year-on-year by 2.2 per cent and 4.7 per cent respectively. The increase in Goods was contributed by the durable and non-durable goods.

Meanwhile, compared to November 2022, the Services index increased by 2.0 per cent while the Goods index decreased by 0.8 per cent.

For the period January to December 2022, the Goods and Services indices increased by 3.1 and 4.5 per cent respectively, compared to the same period in 2021 **(Table 7)**.

Consumer Price Index Technical Notes

1. Concepts and Definitions

- 1.1 The Consumer Price Index (CPI) is a measure of the average change of prices paid by the household for a fixed 'basket' of goods and services over a period of time. The 'basket' of goods and services represents the average consumption pattern of the majority of households in Brunei Darussalam and it is derived from the results of a Household Expenditure Survey. The CPI is solely a measure of price changes and not a measure of changes in general cost of living.
- 1.2 As the CPI reflects the average changes in the prices of consumption goods and services, it is mainly used as a measurement of the rate of inflation. The CPI is also used as a deflator of other economic series such as the conversion of Gross Domestic Product (GDP) from current price values to constant price values.
- 1.3 The CPI basket covers a wide range of goods and services, classified according to the United Nation's "Classification of Individual Consumption According to Purpose (COICOP)". The goods and services are based on the final consumption expenditure of households. However, imputed rentals of owner-occupied housing and household expenditures abroad are excluded. Non-consumption expenditures such as donations, remittances, repayments of loans and purchase of real estate are also excluded.
- 1.4 The CPI can also be classified by the type of goods, according to their durability, and services, as follows:
 - **Durable goods** : Goods that are used repeatedly or continuously over a long period of time (e.g. furniture, household equipment, vehicles)
 - Semi-durable goods : Goods that are used repeatedly but their expected lifetime use is less than for durables and their purchaser's value is significantly less (e.g. clothing, footwear, glassware, games, toys, household textiles)
 - Non-durable goods : Goods that are for single use only (e.g. food and drink)
 - **Services**: Services such as education, health, personal services.
- 1.5 The base year is used as the reference year for computing the weights of the CPI basket based on the results of the Household Expenditure Survey (HES). However, for the computation of price relatives, the average prices of the current month are compared with those of the previous month, instead of the average base year prices. The CPI calculation uses the chained index method, whereby the ratio of the average prices of the current month and the previous month is multiplied with the index value of the previous month.

2. Measurement of Changes in the CPI

- 2.1 The following changes are measured for the CPI:
 - **Year-on-year changes**: the percentage change between the current month and the same month in the previous year;
 - Month-on-month changes: the percentage change between the current month over the previous month; and
 - **Period-on period changes**: the percentage change between the average index of the year-to-date compared to the same period the previous year. For example, the average index from January to June of the current year is compared to the average index from January to June the previous year.
- 2.2 The **contribution to change** column provides information on which goods or services have contributed most to the changes in the index. It is calculated by multiplying the weight of a particular item or group of items with the monthly change in the index for this item or group of items.
- 2.3 The annual inflation rate is taken as the percentage changes between the annual index of the reference year and that of the previous year.

3. Rounding Figures

3.1 The indices and percentage changes will be published to one decimal place in the CPI Report while significantly small non-zero digits will be published to one significant figure. However, the computation of percentage changes and contribution to changes are based on the unrounded index values.

4. Base Year of CPI

4.1 The CPI was rebased using data from the Household Expenditure Survey (HES) to reflect the latest consumption patterns of goods and services by households. The latest base year for the CPI was in 2015.
