**WORLD TRADE ORGANIZATION:  
THE 4<sup>TH</sup> TRADE POLICY REVIEW OF BRUNEI DARUSSALAM**

**GENEVA, SWITZERLAND  
27 – 29 November 2024**

1. The World Trade Organization (WTO) Fourth Trade Policy Review (4<sup>th</sup> TPR) of Brunei Darussalam, took place from 27 to 29 November 2024 in Geneva, Switzerland. The meeting was chaired by His Excellency Adamu Mohammed Abdulhamid, Ambassador of Nigeria and Chair of the Trade Policy Review Board. His Excellency Mzukisi Qobo, Ambassador of South Africa to the WTO served as a discussant to meeting. The Brunei Darussalam delegation was led by Yang Mulia Dr. Hajah May Fa'ezah binti Haji Ahmad Ariffin, Permanent Secretary (Economy, Trade and Industry) of the Ministry of Finance and Economy.
2. Her Excellency, Dk Mazlizah Pg Hj Mahalee, Permanent Representative of Brunei Darussalam to the United Nations (UN), WTO and other international organisations in Geneva, Switzerland was also present, together with representatives from other WTO members.
3. The Trade Policy Reviews is an exercise, mandated by the WTO, in which member countries' trade and related policies are examined and evaluated at regular intervals. Significant developments that may have an impact on the global trading system are also monitored. All WTO members are subject to review, with the frequency of review depending on the country's size. The basis for the review is a report by the WTO Secretariat and a report by the Government of Brunei Darussalam.

4. For Brunei Darussalam, TPRs are generally conducted every seven years under the WTO's standard review cycle for developing countries. The 3<sup>rd</sup> TPR was held on 10 to 12 February 2015.

**SEMAKAN DASAR PERDAGANGAN BRUNEI DARUSSALAM KALI KE-EMPAT**

**27 – 29 NOVEMBER 2024**

1. Pertubuhan Perdagangan Dunia (World Trade Organization (WTO)): Semakan Dasar Perdagangan Brunei Darussalam kali ke-empat telah diadakan pada 27 hingga 29 Julai 2024 bertempat di Geneva, Switzerland. Mesyuarat WTO telah dipengerusikan oleh Tuan Yang Terutama Adamu Mohammed Abdulhamid, Duta Besar Nigeria dan Pengerusi Lembaga Semakan Dasar Perdagangan. Tuan Yang Terutama Mzukisi Qobo, Duta Besar Afrika Selatan ke WTO bertindak selaku pembahas pada mesyuarat berkenaan. Manakala, delegasi daripada Negara Brunei Darussalam telah diketuai oleh Yang Mulia Dr Hajah May Fa'ezah binti Haji Ahmad Ariffin, Setiausaha Tetap (Ekonomi, Perdagangan dan Industri) di Kementerian Kewangan dan Ekonomi.
2. Turut Hadir pada mesyuarat berkenaan ialah Puan Yang Terutama Dayangku Mazlizah binti Pengiran Haji Mahalee, Perwakilan Tetap Negara Brunei Darussalam ke Pertubuhan Bangsa-Bangsa Bersatu, WTO, organisasi-organisasi antarabangsa lain di Geneva, Switzerland berserta ahli-ahli WTO yang berkaitan.
3. Kajian Dasar Perdagangan adalah salah satu latihan yang telah dimandatkan oleh WTO, yang mana, perdagangan berserta dasar-dasar yang berkaitan daripada ahli-ahli anggota akan diteliti dan dinilai pada masa yang sama. Perkembangan penting yang dapat memberikan impak kepada sistem perdagangan global juga akan dipantau. Kekerapan semakan bagi kesemua ahli anggota WTO adalah tertakluk kepada saiz sesebuah negara. Semakan asas adalah laporan daripada Sekretariat WTO dan laporan Kerajaan Brunei Darussalam.
4. Bagi Negara Brunei Darussalam, TPR secara lazimnya akan dijalankan setiap tujuh tahun sekali mengikut standard kitaran kajian WTO bagi negara-negara membangun. TPR kali ke-3 telah dilaksanakan pada 10 hingga 12 Februari 2015 yang lepas.
