## EXIT & ENTRY SYSTEM (EES)

Exit and Entry Charges Act, Chapter 232

### FREQUENT COMMUTER PASS(FCP)

Eligibility:

- Bruneian or Malaysian studying across the border
- Bruneian or Malaysian working across the border
- Travel records of at least fifteen (15) trips per month (entering or exiting) via land control post

### POWERS AND ACTION THAT CAN BE TAKEN UNDER EXIT AND ENTRY CHARGES ACT (CHAPTER 232)

Section 6 :- An exit charge and an entry charge shall be payable on every occasion any person intends to enter or leave, or enters or leaves, Brunei Darussalam by land respectively.

Section 12 :- Where a person has committed or reasonably believed by the Controller or any officer of Customs to have committed an offence under Section 6 of Exit and Entry Charges Act (Chapter 232), the Controller or officer of Customs may prohibit such person from entering or leaving Brunei Darussalam.

Section 16 :- The Controller or any person authorised in writing in that behalf of the Controller may compound any offence against Exit and Entry Charges Act (Chapter 232) by collecting from the person reasonably suspected of having committed that offence a sum not exceeding BND500.

## CAJ PERKHIDMATAN (CaP) Rate:



This charge will be imposed to all citizens who intend to leave or enter Brunei Darussalam through the land control posts (checkpoints) via vehicle or as a pedestrian for each one-way trip.

## ATTENTION

Please apply and pay the Caj Perkhidmatan (CaP) in advance before travelling.

Travel documents must be valid of at least three (3) months at the time of application and vehicle license must be valid during travelling.

QR Code will be issued upon payment.

- Payment must be made in advance before cross-border travel.

## CATEGORIES EXEMPTED FROM PAYING CaP

1. Occupants of the following vehicles:
  - Vehicle belongs to the Government of His Majesty the Sultan and Yang Di-Pertuan of Brunei Darussalam or a government of another country when in use for official purpose;
  - Military vehicle;
  - Firefighter, Ambulance and Police vehicle;
  - Vehicle for funeral purposes.
2. A child of the age of two (2) years or below;
3. Consular officers and consular employees under the Consular Relations Act (Chapter 118) and members of their families; and
4. A diplomatic agent under the Schedule of Diplomatic Privileges.

Note:

- For those listed in the exemption category are still required to apply for EES Pass.
- Overpayment is Non-Refundable.
