Dalam memperkemaskan lagi proses penubuhan syarikat dan memudahcara pengemaskinian struktur pengarah syarikat, Bahagian Pendaftaran Syarikat-Syarikat dan Nama-Nama Perniagaan (ROCBN), Kementerian Kewangan dan Ekonomi ingin memaklumkan kepada orang ramai khususnya para pemilik-pemilik syarikat bahawa dokumen "***Statement of Non Disqualification to Act as Director***" tidak lagi diperlukan untuk dimuat naik ke laman sesawang *One Common Portal* (OCP) (www.ocp.mofe.gov.bn) semasa menghadapi permohonan penubuhan syarikat atau pengemaskinian struktur pengarah syarikat.

Dokumen tersebut telah **ditukar ganti** kepada **borang pengisytiharan "*Statement of Non Disqualification to Act as Director*" secara atas talian** yang disediakan dalam platform berkenaan.

**ENHANCEMENT IN ONE COMMAN PORTAL:
ONLINE DECLARATION
"STATEMENT OF NON DISQUALIFICATION TO ACT AS DIRECTOR" FORM**

In streamlining the process of incorporating a company and facilitating the updating of a company's Director structure, the Registry of Companies and Business Names Division, Ministry of Finance and Economy would like to inform the general public particularly company owners' that the submission of the document titled "***Statement of Non-Disqualification to Act as Director***" is **no longer required to be uploaded** via the One Common Portal (OCP) (www.ocp.mofe.gov.bn) when submitting application for the incorporation of a company or updating of a company's Director structure.

It will now be replaced by **an online declaration "*Statement of Non Disqualification to Act as Director*" form** in the OCP platform.

This enhancement will take effect on **Monday, 1st December 2025**.
