

0 INTRODUCTION

Timber nomenclature is confusing as there can be more than one name available for each timber. These names can be derived from the local vernacular names applied to the trees themselves, or from commercial trade names. This is further compounded by the fact that timber are often derived from more than one species, and therefore, bear more than one local vernacular name. While these vernacular names are perfectly acceptable when applied to the trees from which these timbers are derived, they would only create confusion if all of them were to be applied to the timbers. In a timber-rich country such as Brunei Darussalam, where there are literally thousands of timber producing trees available, it would be almost impossible to conduct cohesive trading if all these timbers were to be sold by their vernacular names. However, it is fortunate that while the differences between species are very apparent among the trees, the timber produced from closely related species are often not distinguishable. Therefore, for trading purposes, these closely related species are sold under one trade name.

In order to streamline the nomenclature of the timbers in the market, and to avoid confusion created by the myriad of names such timbers have, it is felt that a standard document stating the Standard Trade Names will be useful, especially as a reference work to settle any dispute that may arise. This standard establishes the Standard Trade names of the commercial timbers found in Brunei Darussalam.

Since Brunei Darussalam is a nett importer of sawn timber, many foreign timbers are found in the local market. Besides the utility timbers imported to augment the supply of local timbers, would famous timbers such as Teak and Maple are often imported for speciality uses. Therefore, it is felt that the inclusion of the more commonly imported timbers will enhance the usefulness of this document.

To further increase the working value of this document, other information such as some common uses and other trade names which the timbers are known in other countries are provided. It is hoped that with such extra information, this document will be a more complete reference document.
